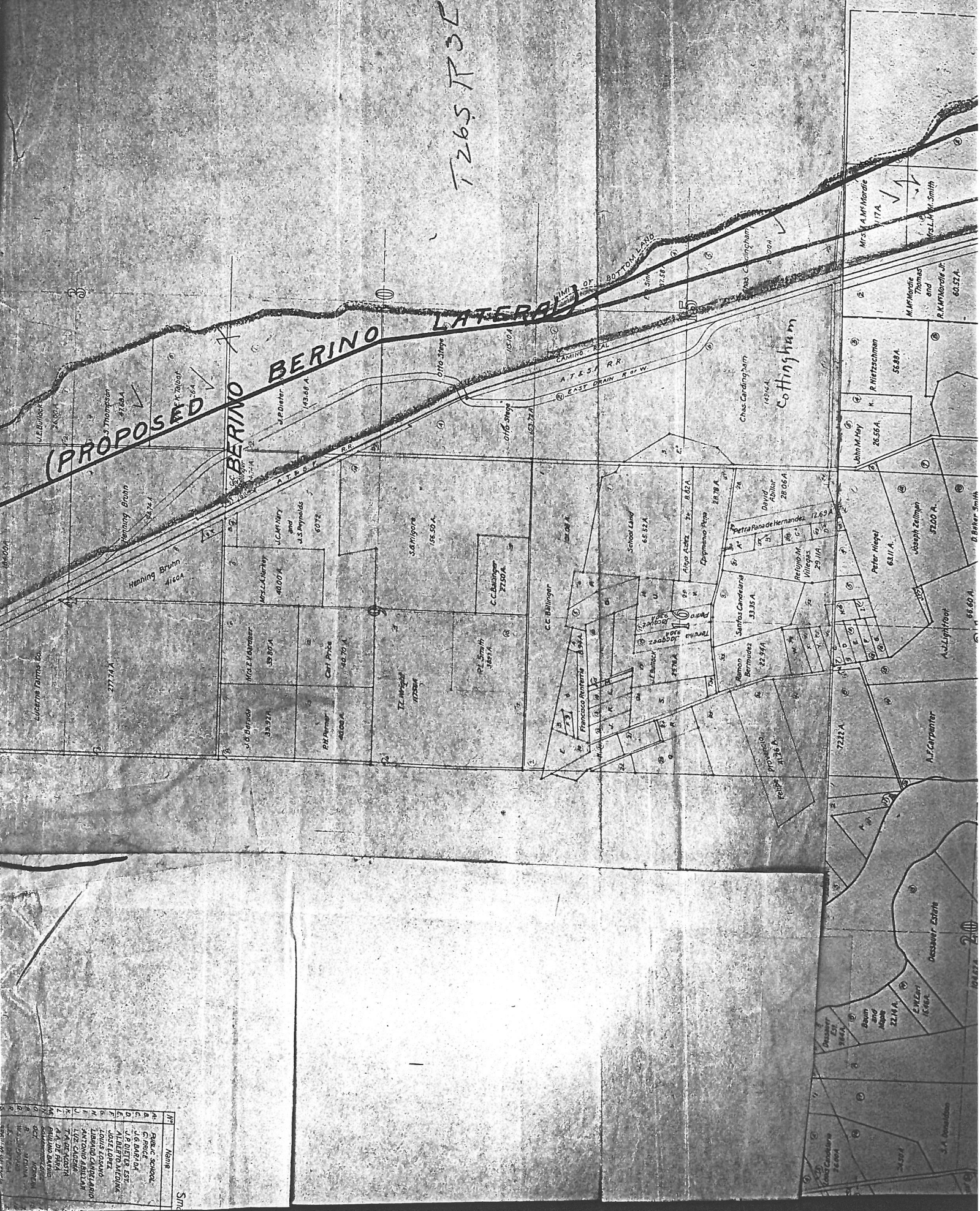

**PROPOSED BERINO LATERAL**

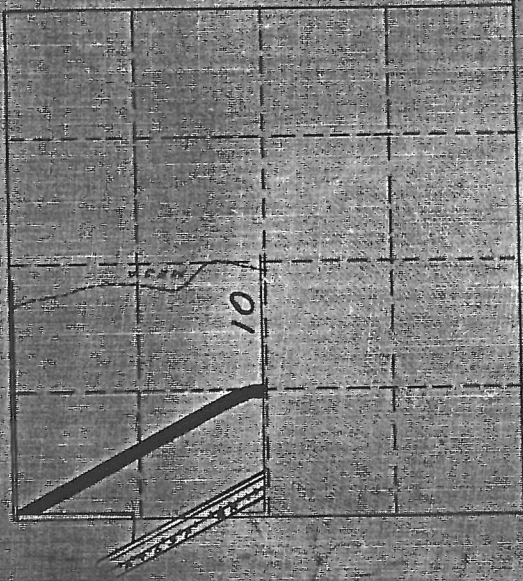

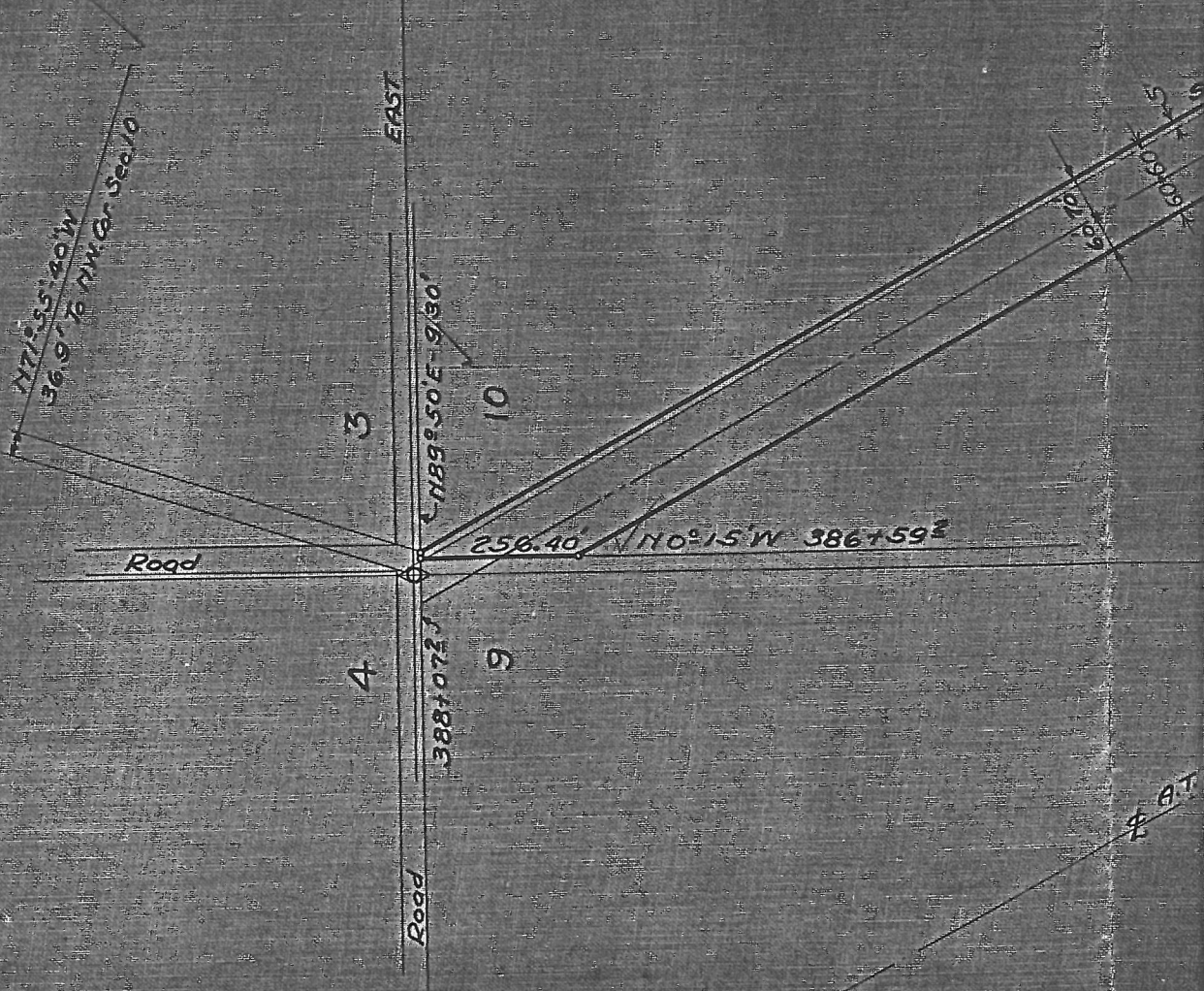


LOCATION PLAT
