This firm represents Haciendas Adobe Development, LP, owner and developer of Alta Valle Del Sol Subdivision ("Subdivision"). The Subdivision is located adjacent to Canutillo Lateral ("Lateral") in El Paso's Upper Valley. According to a Survey obtained by our client, the property line for the Subdivision is located on the slope of service road located adjacent to the Lateral. Our client has been working with Mr. Ruben Nevarez of your office to discuss the placement of the rockwall for the Subdivision. It has been determined that the rockwall should be placed five (5) feet in from the Subdivision property line to insure that the slope is not undermined. Our client has agreed to this location and has further agreed to convey the property east of the rockwall by Gift Deed to the District. I have attached a draft legal description of the property line that is to be conveyed to the District for your review ("Proposed District Property").

The plat for the Property is currently being revised to accommodate the transfer of the Proposed District Property. I appreciate your assistance with this matter and look forward to hearing from you.




