EXTENSION AND AGREEMENT

WHEREAS, On January 23, 1913, Union Mercantile Company, acting through P. H. Bailey, President, made, executed and delivered to Parlin & Orendorff Implement Company a certain promissory note in the sum of One Thousand and Forty six Dollars and Thirty Six Cents (\$1046.36), which amount it promised and became liable to pay to said company on October 15, 1913;

Whereas, thereafter said note was assumed by G. F. Worden Company, a corporation, and said corporation did on the 11th day of March, 1915, execute and deliver a certain deed of trust to F. K. Garver, trustee, for the better security of said indebtedness, which is duly recorded in Book 96, Page 63, Records of Deeds of Trust of El Paso County, Texas, conveying Lots 1, 2, 3, 4 and 5 in Block No. 3 in Canutillo, El Paso County, Texas, according to the plat filed in the office of the county clerk of said county by El Canutillo Town Site & Land Company, also fractional lots 12, 13, 14 and 15 in Block 2 of the said town according to the said plat; and,

Whereas sundry credits have been made on said note and a portion of said property above described has been released from the lien of said deed of trust; and,

Whereas H. H. Bailey & P. H. Bailey doing business as the \_\_\_ has requested an extension of the balance due on said note to December 15, 1917, and said Ranch Supply Company has acquired the remainder of said land covered by said deed of trust, and has assumed, and does hereby assume, the payment of the balance of said note,

Now, Therefore, in consideration of such extension, which has been duly granted by Parlin & Orendorff Implement Company, a corporation, said H. H. Bailey & P. H. Bailey does hereby promise to pay said note and the balance due thereon all according to its face, tenor and effect on the 15th day of December, 1917.
