STATE OF TEXAS, (COUNTY OF EL PASO.)

WHEREAS, on April I3, I907, C. L. North of the County of El Paso and State of Texas, did execute, acknowledge and deliver to B. F. Hammett a certain deed of trust on the following described real estate lying and being in the County of El Paso and State of Texas, to wit:

Whereas, thereafter, to wit: on May 22, I909, P. H. Bailey purchased the premises above described, and as a part of the purchase price thereof assumed the payment of the hereinbefore described notes, and at such time the payment of said notes was extended to April I3, I9I3; and

Whereas, thereafter and prior to January, I9IO, the said notes were transferred by the said B. F. Hammett though the deed of trust securing the same was not then transferred of record; and

Whereas, the said B. F. Hammett in January, I9IO, departed this life leaving him surviving as his only heirs, Mary S. P. Hammett, his wife, and Guy Hammett Farrer, the wife of B. L. Farrer, Paul P. Hammett, and B. F. Buel Hammett, a minor, who was the deceased grandson; and

Whereas, the said notes hereinbefore mentioned were at the time of their maturity extended, being paid by the said P. J. Bailey on March 28, 1913, Paul P. Hammett, as trustee and heir of B. F. Hammett, together with Mary S. P. Hammett and Guy Hammett Farrer joined by the latter's husband B. L. Farrer, executed a release of the deed of trust lien securing the said notes drawn in favor of C. L. North and Pearl H. Bailey, but at that time no release was executed by this guardian in behalf of the other heir, the said B. F. Buel Hammett; and

Whereas, by an order of date June 19, 1915, and recorded at page___ of Book___, of the Minutes of the Probate Court of El Paso County, Texas, I, Mary S. P. Hammett, the duly appointed and acting guardian of B. F. Buel Hammett, was authorized to execute and deliver to and in favor of C. L. North, P. H. Bailey and J. R. Fisk, a good and sufficient release of the apparent interest of the said minor in the deed of trust

lien against the premises above described, the said release to be executed on payment of all costs in this behalf by the said J. R. Fisk; and

Whereas, all costs in this behalf have been duly paid by the said J. R. Fisk;
Now, Therefore, for and in consideration of the premises, I, Mary S. P. Hammett, guardian of the estate of B. F. Buel Hammett, have this day and do by these presents release, discharge and quitclaim unto the said C. L. North, P. H. Bailey and J. R. Fisk, their heirs or assigns, all the right, title and estate in and to the premises above described, which the said minor, B. F. Buel Hammett, may be entitled to by virtue of the said deed of trust hereinabove described, and by virtue of said minor being an heir of the said B. F. Hammett. And I, as guardian aforesaid, do hereby declare the premises above described fully released and discharged from any and all liens created by virtue of said deed of trust above mentioned, sofar as the said minor, B. F. Buel Hammett, is concerned.
