NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of the sum of \$1.00 cash to us in hand paid, and for the purpose of correcting the records and placing the title to all of the hereinafter described property in the grantees herein, we, P. H. Bailey and W. H. Glenn, of the County of El Paso and State of Texas, have Granted, Sold and Conveyed, and by these presents, do Grant, Sell and Convey unto F. B. Burnett and Sallie S. Burnett of the County of El Paso and State of Texas, all that certain tract or parcel of land, lying and being situated in the Co/unty of El Paso and State of Texas, to wit:

Fractional Lots 12, 13, 14 and 15 in Block 2 of the El Canutillo Townsite according to the plat of said El Canutillo Townsite recorded in Vol.132, page 646, of the records of deeds of said County, to which reference is here made, and also a strip of land 10 feet wide, adjacent therto and extending the entire length of the Southern extremity of said Block, being a part of Central Avenue of said Canutillo Townsite in the form of a rectangle 10 feet wide and 64.53 feet long.
