I, Mrs. Ada Krakauer, a widow

of the County of El Paso, State of Texas for and in consideration of the Sum of One and no/100 (\$1.00) Dollar, to me in hand paid by the United States of America pursuant to the Act of Congress of June 17, 1902 (32 Stat. 300) and Acts amendatory thereof and supplemental thereto, and as a further consideration the constructing by the United States of a standard farm bridge for the irrigation of land of the Grantor herein, said bridge to be constructed at Station 4 plus 00, the receipt of all of which is hereby acknowledged, but in consideration of the benefits to be derived by such construction, the Grantor for my self and my heirs and assigns, agrees that I will maintain said bridge in good condition and hereby releases the United States from all expense of or damage occurring from lack of proper maintenance.

do by these presents Bargain, Sell, Release and Forever Quit-Claim, unto the said

The United States of America, its

heirs and assigns all my right, title and interest in and unto that tract or parcel of land lying in the County of El Paso, and State of Texas, described as follows, to-wit:

A tract of land in the southeast quarter of the northeast quarter (SE 1/4 NE 1/4) Section Nineteen (19), and the Southwest quarter of the Northwest quarter (SW 1/4 NW 1/4) Section Twenty (20), Township Thirty-three (33) South, Range Eight (8) East, United States Reclamation Service Survey and Surveys No's. 10 and 11 of the San Elizario Grant and being sixty (60) feet wide, lying thirty (30) feet, measured at right angles, on each side of the center line for the Crismor Lateral, said center line being described as follows:

Beginning at a point on the east bank of the old Clint Ditch, said ditch having a bearing South 37°08' East, and from which point the Southeast corner of said Section Nineteen (19) bears South 18°30' East, two thousand eight hundred fifty-six and five tenths (2856.5) feet; thence North 75°51'30" East, one thousand fifty-six (1056.0) feet; thence North 83°47'30" East, six hundred forty-eight and eight tenths (648.8) feet to a point on the property line between land of the Grantor herein and C. N. Bassett, said property line having a bearing South 37°07'30" East, and terminating with said property line and from which point the Southwest corner of said Section Twenty (20) bears South 14°06' West, three thousand one hundred thirty-one and seven tenths (3131.7) feet; said tract of land containing two and thirty-five hundredths (2.35) acres, more or less.

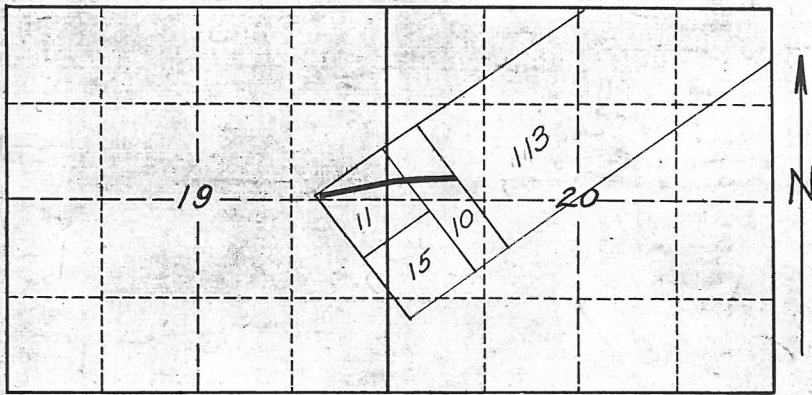

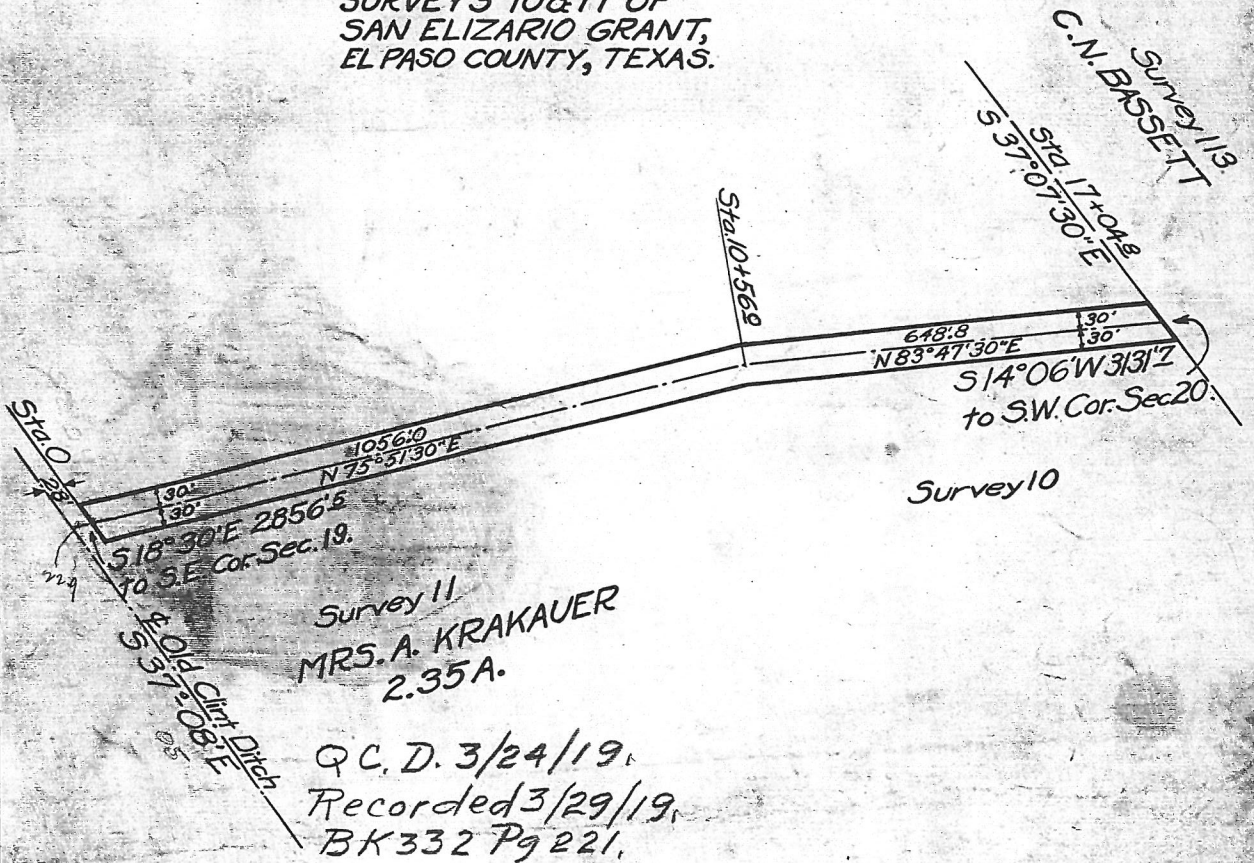

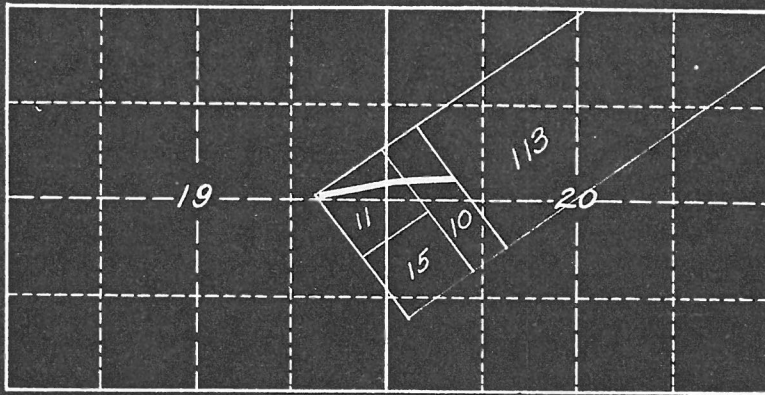


LOCATION PLAT

 EL PASO COUNTY, TEXAS.

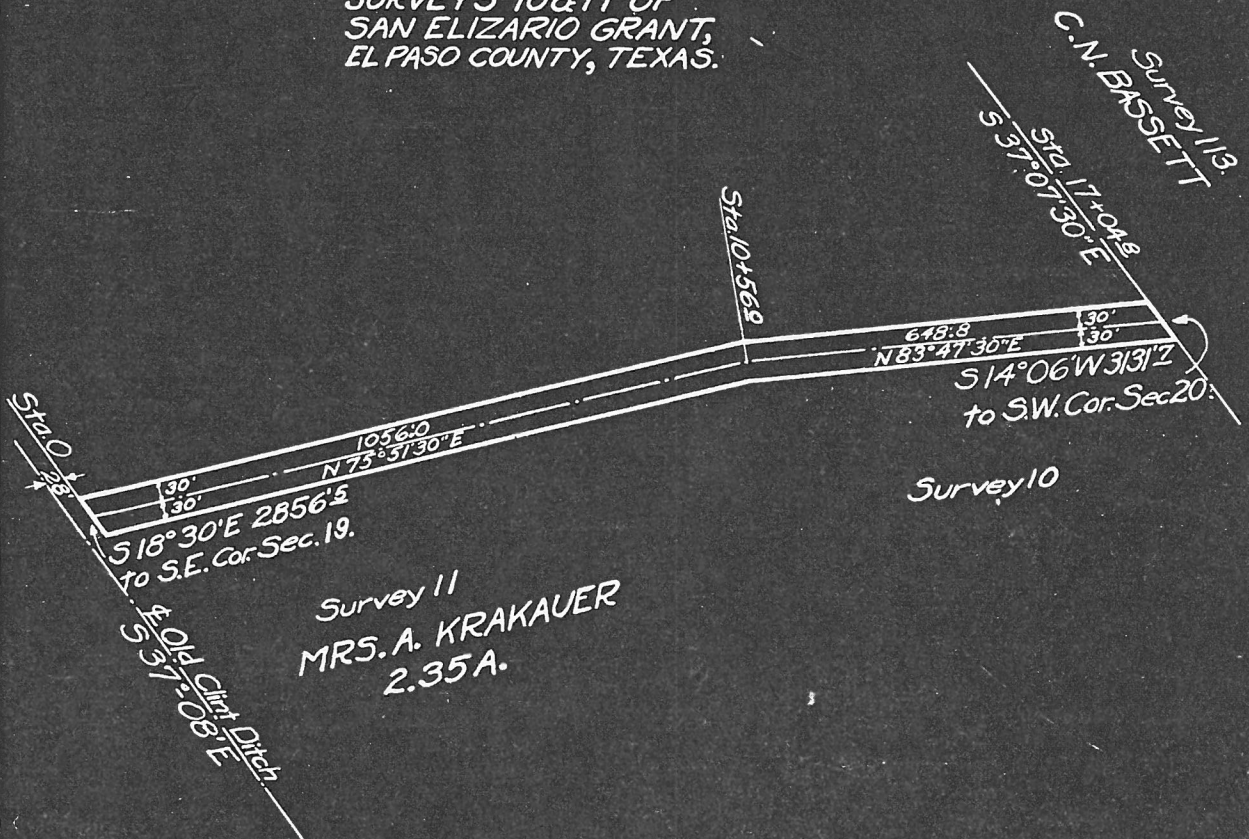
