We, the undersigned, owners of land, hereby petition the United States, in lieu of utilizing in the future the present channel of the Rio Grande between Tornillo Canal heading and the lower junction of the river and the rectified channel of the Rio Grande near San Elizario Island Monument No. 21 as a drain and wasteway, to construct a canal for the purpose of carrying waste and drain water upon such final location and according to such final specifications as may be approved by the proper officers of the United States as approximately located and shown on the plat attached hereto and made a part hereof and marked Exhibit "A", and we hereby agree that if this petition is granted and such proposed wasteway channel is hereafter built by the United States, we will, upon demand therefor, execute and deliver to the United States a good and sufficient quitclaim deed conveying a strip of land approximately 140 feet wide across our lands, being a tract or tracts lying in El Paso County, Texas.

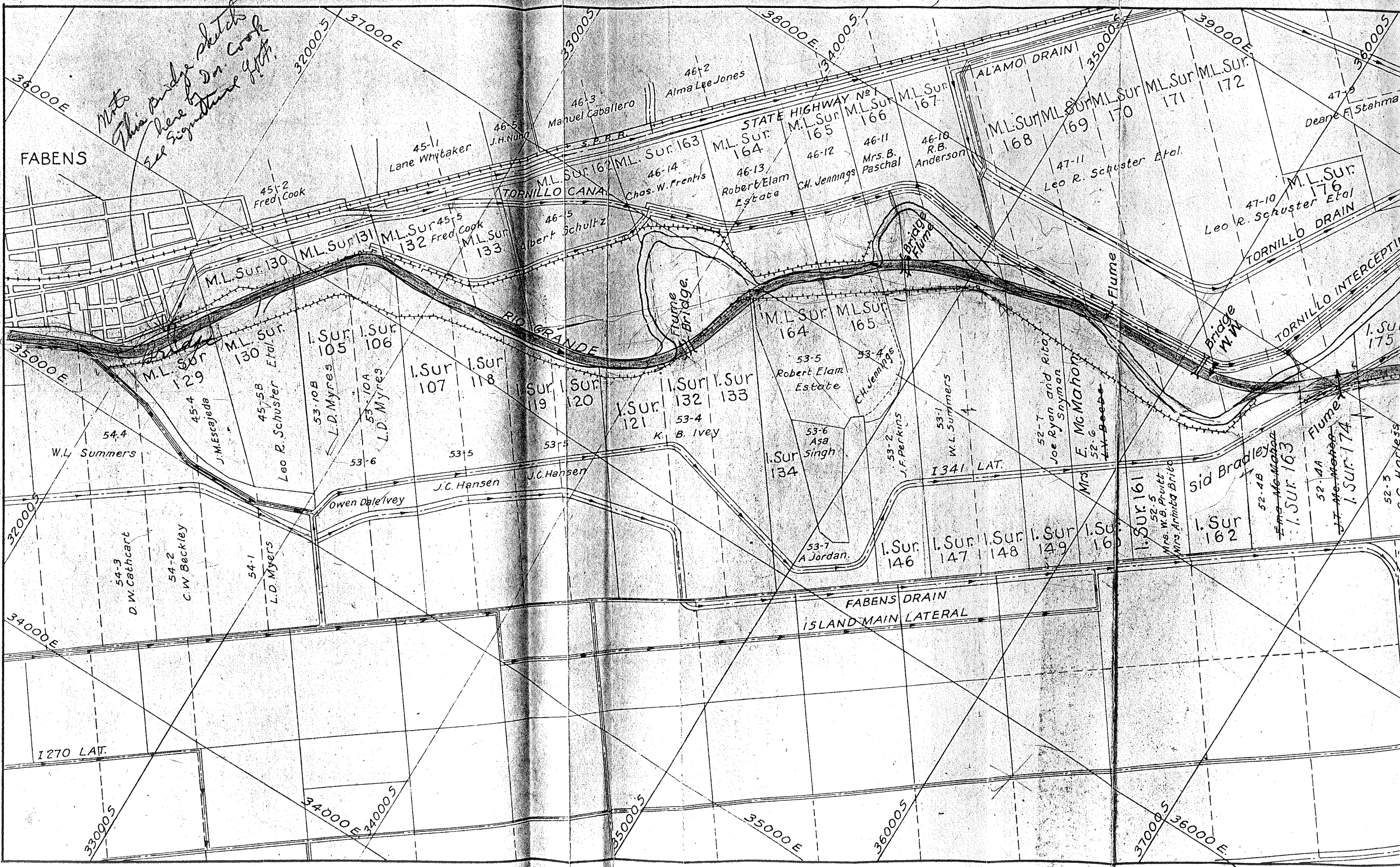
