Twenty-nine (29) thirty (30) thirty-one (31) and thirty-two (32) in Block No. Sixteen (16) in Moreheads Addition of the town of El Paso as shown by the map of said Addition made by A. C. Savage, City Engineer, January 30th 1882 and now known as Franklin Heights, being same lands transferred to A. H. Holmes by E. S. Newman & wife by deed of date Nov. 3rd 1893 and of record in Book 18, page 576 record of deeds for El Paso County, Texas, which said last mentioned deed is hereto referred, and made a part hereof.
