WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That N. Jarvis, and B.L. Jarvis, his wife, of the County of El Paso, State of Texas, in consideration of the sum of One hundred and ten and no/100 (\$110.00) Dollars, to them in hand paid by The United States of America, in pursuence of provisions of the Act of June 17, 1902 (32 Stat. 388), and Acts amendatory thereof and supplementary thereto the receipt of which is hereby acknowledged have Granted, Sold and Conveyed, and by these presents do Grant, Sell and Convey unto the said The United States of America, all that certain tract or parcel of land lying in the County of El Paso and State of Texas and more particularly described as follows, to wit:

A tract of land lying and situate in El Paso County, Texas, approximately 12 miles south of the Catholic church in the town of Socorro, Texas and in the southwest quarter southwest quarter (SW2SW2) Section eighteen (18), and the northwest quarter northwest quarter (NW2NW2) Section nineteen (19) Township

thirty two (32) South Range seven (7) East Bureau of Reclamation survey, being also in survey 166 of the Socorro Grant and more particularly described as follows:
