KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned owners of water rights in the ~~Three Saints~~ Community Ditch ~~Wasteway~~, in El Paso County, Texas, for and in consideration of the benefits to accrue to us, respectively, by reason of the reconstruction, enlargement and improvement of the said ~~Three Saints~~ Community Ditch ~~Wasteway~~ to be hereafter performed by the United States of America, hereby disclaim and release all our rights, title and interest in and to the said ~~Three Saints~~ Community Ditch ~~Wasteway~~ as the same is now constructed and in existence, as shown on blue print attached hereto and hereby made a part hereof, and agree that the United States, pursuant to the Act of Congress approved June 17, 1902 (32 Stat. 388) and acts amendatory thereof and supplementary thereto, may take charge of, operate and maintain, and control said Wasteway and all appurtenances thereof, and shall have the right to reconstruct, enlarge and otherwise improve the same in any manner deemed necessary by the proper officers of the United States in order that there may be afforded superior facilities for the irrigation of the lands tributary thereto.
