- 2. The blueprint plat accompanying the deed indicates that D. F. Metcalf is the owner of a tract adjoining that of the grantor while the description in the deed (lines 5 & 7) gives the name of the adjoining owner as D. M. Metcalf. The third line from the last of the description says "northwest corner of said Sec. 7" while blueprint shows "northeast corner". The description is probably incorrect for later it says "west" and then "east"
- 3. Corrections should be initialed by the grantor on the margin of the deed and the corrections noted on the county records,
